### **ADMISSION NOTICE**

**SESSION: 2024-25**

Registration for admission into LKG class of DAV OMC Public School, Jilling, Keonjhar shall be opened from **15th Feb 2024** for the **Session 2024-25**. Parents interested for admission of their child into LKG may register their names and collect Registration Forms available in the school office from **16th February 2024 to 4th March 2024** during school hours. However, a few seats are laying vacant in classes from UKG to VIII for the same session. Interested candidates may apply and submit their application in the school office before the last date. Admission in classes except LKG is subjected to vacancy in that particular class.

**25% of the seats as per RCFCE Act-2009 are reserved for the candidates belonging to the Weaker Section and Disadvantaged Group of the society. The Weaker Section and Disadvantaged Group candidates are required to register on the Govt.portal [www.rteparadarshi.odisha.gov.in](http://www.rteparadarshi.odisha.gov.in) for admission into entry class(LKG) under sec.12(1)(c) of the RCFCE Act-2009 from 22.02.2024 to 20.03.2024 (1<sup>st</sup> round) and from 10.04.2024 to 24.04.2024 (2<sup>nd</sup> round).**

- 1) Mere registration will not confer right to admission.
- 2) Help desk for offline registration is available in the school office from 10.00 a.m to 1.00 p.m. on all working days.
- 3) **Birth-Certificate, Aadhaar-Card & Residence-Certificate** is essential for admission.
- 4) Before registration, detailed information regarding parameters of Admission can be viewed in the school notice Board and website.

2. Scanned copy of documents to be submitted at the time of registration.
  - a) **Birth Certificate issued by the competent authority.**
  - b) **Aadhaar Card of the child and Residence certificate of the Parents.**
  - c) **Passport Size photograph of the child along with the parents at the space provided.**
3. Under no circumstance date and time as mentioned in admission notice for submission of above documents can be extended.
4. For the entry class i.e. LKG children whose date of birth falls between 01.04.2019 and 31.3.2020 (both days inclusive) only are eligible for registration for the academic session 2024-25.
5. **Registration of Special Category Candidates at the Govt.portal [www.rteparadarshi.odisha.gov.in](http://www.rteparadarshi.odisha.gov.in) in free of cost .**
  - a) In order to apply for admission in 25% reserved seats in private schools under RCFCE Act., parents / guardian of eligible children will visit the portal mentioned above and can apply from the Common Service Center or Cyber cafes or by themselves or with the support of concerned school or BEO. The parent/guardian will be able to select multiple schools for admission as per his/her choice in order of priority .If the parents/guardians of the eligible children approach the Block Education Officer (BEO) with all necessary documents. Then the concerned BEO will facilitate the application process through available resources in his/her office.
  - b) **Documents required for Disadvantaged Group (ST / SC / SEBC- Non –Creamy Layer) & Economically Weaker Section.**
    1. Birth Certificate issued by competent authority.
    2. Identity Proof of Parents/guardian(Aadhaar Card/ Voter ID /Kissan Photo Pass book/Ration Card /PAN card /MNREGA job card /Passport/Photo attested by any Gazetted officer / Disability Certificate issued by competent authority).



3. Caste certificate by competent authority in case of SC/ST/SEBE.
  4. Address Proof (Aadhaar Card/ration Card/ Bank statement /Vote ID card / Driving License/Gas connection bill which is not more the 3 months old /Farmer Photo passbook/KCC Card)/Registered lease /sale/Rent Agreement/MGNREGA job card/passport/Certificate in support of address given by the Sarpanach / Counsellor/ Corporator/ Labour card/the certificate in support of address given by MLA/Gazetted Officer written on their letter head.
  5. Any poverty alleviation card issued by the Govt. /Certificate of income issued by the competent authority in case of EWS candidates.
  6. Disability Certificate /HIV positive certificate (in case of parents)issued by the competent authority in case of Children with disabilities(not less that 40%)HIV positive of the parents.
  7. CWC certificate issued by any CWC in case of Orphan.
- c) After submission of application through the respective online portal, parents /guardian of eligible students need to visit the office of the Block Education Officer (BEO),Joda along with original copies of necessary documents .The BEO will validate the application and forward it to the Director of Elementary Education trough the portal.
- d) The competent authority of the Govt. will select the candidate for each school through online Lottery considering their priority and category as per the policy and allot the candidates to the respective schools available in the vicinity of their residence.

  7. Submission of **Incorrect/False/Wrong** information regarding any data required in the admission form may lead to cancellation of the Registration Form of the candidate.
